In March, Governor Lee approved a \$41 million budget to FULLY FUND the Education Savings Account (ESA) Pilot Program in Shelby and Davidson Counties for the 2020-2021 school year. The Voucher Plan was high on the Governor's and our priority list.

There was a small problem. Local governing bodies in Shelby and Davidson Counties, the ACLU, along with a host of others, called the program unconstitutional. The Court agreed. Why? The citizens of the two counties didn't get a say. The State ignored the local government's desire not to participate. The State plans to appeal. But, even if they win, it will be too late for the 2020-2021

school year. AND there's this: the ESA budget was cut from \$41 million to \$250,000. Appropriations Bill | TennCare

Recently the TN Senate passed the Appropriations Bill which SLASHED \$6.6 million

per year of Postpartum Care—a decision that disproportionally impacts African American Women and their newborns. The kicker is that this bill will also STA\$H \$400 million in TennCare RESERVE. TN Department of Health requested that the State use that \$6.6 million to create a

three-year pilot program to extend the postnatal care coverage for women on TennCare from 2 to 12 months. It was estimated 4,000 to 6,500 new mothers would benefit from the pilot. The slash should irk PRO-LIFERS into action: WHY cut a service that saves lives

and money? TN's track record on mother/infant health ain't so good. In 2017 alone, 52 women died within a year of giving birth. And there's this: Tennessee is
